The meeting opened with a moment of silence, followed by the Serenity Prayer at 6:06 pm.

#### **Reports:**

- Minutes, Financial, Telephone, and Website report, were submitted, and approved.
- District 7 Report- Annual Picnic was on July 9<sup>th</sup> in Ionia where our delegate read his report. Next
  District 7 business meeting will be on September 3<sup>rd</sup> at the South Club, hosted by The Friday
  Night Book Study.
- Monthly Newsletter posted on website.

#### **Roundup Business:**

- Discussed venue for 2023 Roundup. St. Peter and Paul available for same price. Lisa D. from the
  N. Club was in attendance to discuss N. Club as a venue option. A <u>MOTION</u> was made, seconded,
  and passed to <u>TABLE</u> further discussion until next month when Lisa will present a formal bid to
  the Committee.
- Discussed reservations and travel arrangements for Chris R. (2023 Main Speaker), Chris will make
  his own travel arrangements which the committee will reimburse him for. We will determine the
  hotel once we do a little more research and pick a venue.
- Discussed 2024 Main speaker options. Suggested: Earl H., Theresa F., and Quincy W. A Motion
  was made, seconded, and passed to reach out to Quincy W. to request her to be our main
  speaker for 2024. Susie will reach out to her.
- Discussed theme. Past themes shared. Please bring ideas to September Business Meeting.
   TABLED.
- Billy K. is retiring but still willing to cater event if asked. <u>TABLED</u> until venue is chosen.
- Roundup dates chosen for the next four years; 2023 (April 22), 2024 (April 27), 2025 (April 26), and 2026 (April 25). This enables us to schedule the speakers well in advance.

#### **Old Business:**

- Bylaws update, a <u>MOTION</u> was made, seconded, and passed to post the new bylaws in the KCCO, on the website, and to include them in the next newsletter for further feedback and transparency purposes. The proposed, updated bylaws will be voted on at our September business meeting. Please contact Steve C. if you would like a copy to review.
- A2-Posting of KCCO content and speakers discussed, those duties will be performed by the new Trustee #2 (per the new bylaws-when adopted)
- Discussion about lease renewal vs. relocation of KCCO location: Current lease is up 10/31/22.
   Steve C. followed up with current landlords about their other properties that are comparable.
   Currently nothing open and cost is higher at their other locations. Tommy Brann was contacted,

Susie and Mike toured two sites, rent for them (\$3000 & \$1400) would be more than double what we will pay with new lease. A <u>MOTION</u> was made, seconded, and passed unanimously to sign a one-year lease (with our current landlord) and continue to search for a new office space that is more centralized and near a bus line. A "friendly" amendment was accepted to authorize the chairperson to contact our present landlord and finalize the lease at their discretion.

- Answering Service/ 12 Step Call List discussion: Steve C. continues working on updating the call
  list. Share at meetings that the list is being updated and more volunteers needed. Contact Steve
  C. to be added.
- We continue to have connectivity challenges with our office telephone line, AT&T is working on trying to diagnose the problem.
- Discussion about website- District 7 administrator given rites to update their content to the
  website. A <u>MOTION</u> was made, seconded, and passed unanimously to give District 7
  administrator "blanket" approval on postings to their page on KCCO website.
- Treasurer still needs to sign papers to be authorized on bank account.
- Discussion about KCCC open positions. A <u>NOMINATION</u> was made for Mike W. to be elected as Trustee #2; he was elected unanimously. Vice -Chairperson and Trustee #3 positions are still open. Please bring to groups. <u>TABLED.</u>
- Literature: Big Books are stocked. Continued back-orders on Daily Reflections and pocket-sized Big Books.
